

Rev Renewables, LLC Job Applicant Privacy Notice for California Residents

Last Update: August 2, 2021

This **Job Applicant Privacy Notice for California Residents** applies solely to Rev Renewables, LLC's ("Rev Renewables") collection and use of personal information of natural persons who reside in the State of California ("you") for a number of purposes connected with evaluating your application for employment with Rev Renewables. We adopt this notice to comply with the California Consumer Privacy Act of 2018 ("CCPA") and any terms defined in the CCPA have the same meaning when used in this notice.

Information We Collect

We collect information that identifies, relates to, describes, references, is capable of being associated with, or could reasonably be linked, directly or indirectly, with you or your household ("Personal Information"). In particular, we have collected the following categories of Personal Information from you within the twelve (12) months preceding the date of the Last Update:

Category of Personal Information	Examples¹
Identifiers.	A real name, alias, postal address, unique personal identifier, online identifier, Internet Protocol address, email address, account name, Social Security number, driver's license number, passport number, or other similar identifiers.
Personal information categories listed in the California Customer Records statute (Cal. Civ. Code § 1798.80(e)).	A name, signature, Social Security number, physical characteristics or description, address, telephone number, passport number, driver's license or state identification card number, insurance policy number, education, employment, employment history, bank account number, credit card number, debit card number, or any other financial information, medical information, or health insurance information. Some personal information included in this category may overlap with other categories.
Protected classification characteristics under California or federal law.	Age (40 years or older), race, color, ancestry, national origin, citizenship, religion or creed, marital status, medical condition, physical or mental disability, sex (including gender, gender identity, gender expression, pregnancy or childbirth and related medical conditions), sexual orientation, veteran or military status, genetic information (including familial genetic information).
Professional or employment-related information.	Current or past job history or performance evaluations.

Personal Information does not include:

- Publicly available information from government records.
- Deidentified or aggregated consumer information.

¹ Examples are provided for illustrative purposes only. Rev Renewables does not collect all of the specific Personal Information provided as examples below.

- Information excluded from the CCPA's scope, like:
 - health or medical information covered by the Health Insurance Portability and Accountability Act of 1996 (HIPAA) and the California Confidentiality of Medical Information Act (CMIA) or clinical trial data;
 - personal information covered by certain sector-specific privacy laws, including the Fair Credit Reporting Act (FCRA), the Gramm-Leach-Bliley Act (GLBA) or California Financial Information Privacy Act (FIPA), and the Driver's Privacy Protection Act of 1994.

Use of Personal Information

We may use or disclose the Personal Information we collect for one or more of the following business or commercial purposes (each, a "Business Purpose"):

- Evaluate applications for employment or internal promotion.
- Comply with our legal obligations.
- Provide you with information, products or services that you request from us.
- As necessary or appropriate to protect the rights, property, or safety of us, our clients, or others.

Rev Renewables will not collect additional categories of Personal Information or use the Personal Information we collected for materially different, unrelated, or incompatible purposes without providing you notice.

Sharing Personal Information

Access to your Personal Information will generally be limited to those individuals with a relevant responsibility, e.g. HR personnel, managers, the administrative team and the legal team. Rev Renewables may disclose your personal information to a third party, including our affiliates, our service providers, and government agencies and law enforcement officials, for a Business Purpose. Rev Renewables does not sell your Personal Information.
